The meeting starts at 9:03. ISMF President Regula Meier welcomes the attendees and the guests present in today's session, namely Irina Gladkikh (Associate Director at the International Olympic Committee, Winter and Recognised Sports and IF Relations) and Azerbaijan Winter Sports Federation (AWSF) Vice-President Florian Sengstschmid.

She excuses President Fuad Naghiyev, who cannot be present. Vice-President Florian Sengstschmid makes a short speech thanking the ISMF and emphasizing that the AWSF is glad and proud to host this important event. Additionally, they are proud that the first ISMF World Cup in Azerbaijan will be staged in January 2025. He then wishes everyone a successful Plenary Assembly.

To conclude the introductory part, a video from IOC President Thomas Bach is shown, welcoming the attendees and wishing all the best to the ski mountaineering community.

8. Information – Rules

8.1. Advertising rules on the race suit

Marketing & Communication Vice-President Ramone Cooper explains that the objective of this project is to have a standard race suit, enhanced with sponsor logos for National Members and athletes, as explained during the workshop of the previous day.

8.2. Transgender Rules

Plenary Assembly in Oviedo approved the taskforce for this sensitive topic. The taskforce, led by Medical Commission President Carron Scrimgeour, has done excellent work. The group consists of members who are experts from various ISMF commissions. We also receive suggestions from IOC delegates on this matter. Following the taskforce's proposal, the ISMF Council on 17 October 2024 approved the Transgender Rules, which will be published on our website as soon as possible. We have aligned our approach with common aspects from other sports and follow a similar direction.

Jerimy Arnold (USSMA) asks why the document was not made available earlier for review and questions. General Secretary Jordi Canals responds that it will be published as soon as possible. President Regula Meier apologizes for the delay. Jerimy Arnold (USSMA) suggests that having the document available now would be beneficial for discussion. General Secretary Jordi Canals apologizes again and explains that the approval was done less than 48 hours ago and, the office is on-site and cannot handle everything simultaneously.

Hermann Gruber (DAV) states that since these are rules, it is appropriate for the Council to vote on them, and there is no need to provide them to the Plenary Assembly in advance. General Secretary Jordi Canals mentions that National Members are welcome in ISMF commissions and are asked to present candidates. There are commissions with empty places, so National Members can propose someone, providing a good opportunity to give them a voice. The Council is always open to receiving National Members' opinions. Councillor Anders Pettersson notes that this is a complex issue requiring specialised



experts. We will give the document to National Members for a deep analysis, and they can come back with proposals if needed.

President Regula Meier clarifies that the Council has the authority to vote on this. The Plenary Assembly can send motions if National Members wish. Regarding the first question, there is no Q&A session because we only offer this opportunity for topics being voted on today. For the second question, we were under pressure. The document was ready for the last Council, but the Council preferred to evaluate it thoroughly and ensure its accuracy before voting officially. Hermann Gruber (DAV) suggests that the rules could be applied from next year and understands that it is not ideal to have them pending for another year. President Regula Meier mentions that the Council has discussed this many times, knowing that there may be adaptations. At least we have a starting point for proceeding with this important project. Jerimy Arnold (USSMA) emphasizes that he does not blame the office, as he knows we work hard. He received reports from a taskforce member and reiterates the need for the document as soon as possible.

The ISMF office manages to share the relevant document, which was recently approved by the Council on 17 October, with the National Members.

Massimo Rinaldi (FISI) asks if we voted last year for this member as provisional and this year as full. Giulia Avagnina (Administration & HR Manager) responds that no, it is completely new. It was temporary because it was only voted on in the Council during the year (art. 8.2 of ISMF Statutes).

Massimo Rinaldi (FISI) states that it is important to have new members because this strengthens us by increasing the pool of nations and expanding the number of professional athletes. However, it is important that these new nations have athletes who can actually compete. Giulia Avagnina (Administration & HR Manager) mentions that Cyprus applied for Olympic Solidarity funds but could not participate due to other issues.

President Regula Meier says that the spirit is to help and support everyone, but we can only do this if we know each other. It is important to interact during general meetings like the Plenary Assembly.

Elvis Toci (ASF) notes that for new nations like Albania, there are often questions that seem obvious to others but are important to them, and they do not know whom to ask. President Regula Meier says that our managers are always available and can be contacted for any simple questions if needed, without hesitation.

14. Information/approval – Next years' Plenary Assembly

14.1. Information: 2025 Plenary Assembly in Cancun, Mexico

Carlos Pruneda Fernández (FEMESKI) gives a brief introduction of the location, showcasing a video. He looks forward to welcoming everyone to Cancun for the 2025 Plenary Assembly.

14.2. Date approval: 2026 Plenary Assembly

Elvis Toci (ASF) mentions that the proposed date of 24 October 2026 usually coincides with the first stage of the FIS World Cup, so it would be better to avoid overlapping the two events. President Regula Meier responds that considerations with regards to the annual financial statements preparation need to be also taken into account and be carefully reviewed, and therefore, a vote on this date cannot be held today.

President Regula Meier asks if October 17 or 31 would be suitable. Andreas Eichwalder (OSV) states that it is difficult to predict future events so far in advance. President Regula Meier then suggests October 17, as it is certain that no FIS events will coincide with this date.

There are no objections or abstentions regarding the decision not to vote on the date of the 2026 Plenary Assembly today. President Regula Meier states that they will return with a proposal as soon as possible.

No vote is held regarding the date of the 2026 Plenary Assembly; the vote is postponed.

Carlos Pruneda Fernández (FEMESKI) notes that the same issue arises for next year's event in Cancun. President Regula Meier asks if there is an official request to change the already voted and approved date for the 2025 Plenary Assembly. There are no objections or abstentions to postponing this decision. Regula Meier consults with Compliance Office President Juan Jesús Ibañez Martin, and it is decided that this point will be voted on at the Extraordinary Plenary Assembly.

15. Milano Cortina 2026

Naoko Maruyama (delegate from Milano Cortina 2026 OGOC) introduces herself with a promotional video of Milano Cortina 2026. She presents key roles, including Davide Canclini as Sports Manager for ski mountaineering, and explains the different locations based on the sports. She outlines that ski mountaineering will have three medals and briefly describes the ski mountaineering programme with dates and disciplines.

Naoko Maruyama (delegate from Milano Cortina 2026 OGOC) shows photos of the race venue and mentions that there will be a test event in Bormio in February 2025 to conduct all necessary tests in advance. Currently, work is underway to equip the venue with the required infrastructure. Athletes will be accommodated in the Bormio Olympic Village (1st wave for alpine ski and 2nd wave for ski mountaineering athletes). The security perimeter will only be accessible with accreditation or a ticket. All team officials must be accredited. Once the qualification period ends, it is important to contact the respective National Olympic Committees for accreditation.

Applications for volunteers and ticketing are already open, so she invites everyone to take advantage of this opportunity.

Charles De Candolle (CBDN) asks if anyone is free to move around Bormio during the Olympic Winter Games and access all areas. Naoko Maruyama (delegate from Milano Cortina 2026 OGOC) explains that there will be many restrictions, and some areas will be reserved exclusively for athletes. However, with a ticket, everyone can access most areas, except those strictly for athletes, staff, or National Olympic Committees/International Federations. Everyone is welcome to attend the competitions (with a ticket).



16. Any other business

No items.

President Regula Meier thanks everyone present and the organisers of the Plenary Assembly in Baku and notes that the workshop has shown that the attendees are actively involved in the life of ISMF. She welcomes criticism as it helps improve the organisation and encourages everyone to ask questions, even if they are critical.

She mentions that there will be a group photo immediately after the meeting, as is done every year. She also encourages everyone to take the opportunity to visit Baku in the afternoon.

Gunel Badalova (host of the Plenary Assembly 2024) announces that the gala dinner will be in the city centre and provides logistical information for the evening.

Afterwards, President Regula Meier declares the Plenary Assembly closed at 12:50.
