

Rules for Use of the Teams Area

Copa del Món Skimo Boí Taüll 2026

1. Purpose and scope

To regulate the use of the space known as the **Teams Area**, intended for national delegations to set up a tent (approx. 3x3 m) as a warm-up area, storage area and shelter from precipitation.

2. Definitions

- **Teams Area:** Area set up by the organization for teams to install tents.
- **Accreditation:** Official event credential that allows access to authorised persons (athletes, technicians and accredited personnel).

3. Access and accreditation

1. **Start of access and set-up:** from **Friday 30 January 2026, 3 p.m.**
2. **Access control:** Only **duly accredited** persons will be allowed access. Accreditation must be shown at each access point.
3. The organization may establish additional filters and controls when it deems necessary for operational or security reasons.

4. Schedules

1. **Race days:** Access **from 07:30 until the end** of the race (estimated at around **14:00**).
2. **Outside of these hours:** access may be restricted or closed according to the organizers' instructions.

5. Tent assembly and safety

1. Each team is responsible for the **safe assembly** of its tent, ensuring **structural reliability and sturdy fastening** against wind, snow and precipitation.
2. Tents must be **properly anchored and weighted** to prevent movement or overturning, minimising any risk to people or property.
3. Any installation that compromises safety, invades evacuation corridors or interferes with event operations is prohibited.

6. Adverse weather and preventive evacuation

1. If the organization detects **complex weather conditions**, it may **require** teams to **dismantle** their tents and **remove** materials.
2. The **official communication** will be made through the **agreed channel** for emergencies between the **LOC** and the **national delegations**, issued by the **Technical Secretariat**.
3. **Mandatory:** **all teams** must comply with the dismantling order **regardless of the time** it is issued.

7. Control during the races

1. During competition hours, the organization will establish a specific **access control point** that must be **respected** at all times.
2. The **maximum cooperation** of teams, athletes and technicians is requested in order to speed up entry and exit.

8. Surveillance and responsibilities

1. **There is no night-time surveillance service** in the Teams Area.
2. The organization is **not responsible** for **theft, loss or damage** to property deposited by teams.
3. Each delegation must manage the **custody** of its equipment and the **security** of its facilities.

9. Compliance and measures

1. Failure to comply with these regulations or the organization's instructions may result in **restricted access** and/or **removal** of the offending team's tent.
2. Any unforeseen situation will be resolved according to criteria of **safety, operability and the general interest of the event**.

Reservation space process

The organization has six 3x3 m tents available for teams that do not have their own.

Teams that bring their own tent must notify the organization before 27 January so that space can be managed appropriately.

This notification must be sent by email to secretary@skimoboitaull.cat identifying the name of the team and the person responsible for setting up the tent.

Requests received after this date will be placed at the back of the queue, and the first teams to do so may have their location changed.

If demand is very high, only one 3x3 m tent per team may be installed.

If we find that demand exceeds the capacity of the space, we will set up other areas near the exit to expand the team area.
